3                   **SUBCHAPTER A. GENERAL PROVISIONS**

4  
5                   **§807.1. Title and Purpose.**

- 7                   (a) These rules may be cited as the Career Schools and Colleges rules.
- 8
- 9                   (b) The purpose of these rules is to implement and interpret the provisions of the Texas
- 10                   Education Code, Chapter 132, Career Schools and Colleges. The Commission shall
- 11                   evaluate each school according to the standards of practice set forth in the Act and
- 12                   this chapter. The Commission will provide assistance, whenever possible, in
- 13                   complying with this chapter.

20                   **§807.2. Definitions.**

21  
22                   In addition to the definitions contained in §800.2 of this title, the following words and

23                   terms, when used in this chapter, shall have the following meanings unless the context

24                   clearly indicates otherwise.

- 25
- 26                   (1) Academic quarter--A period of instruction that includes at least ten weeks of
- 27                   instruction, unless otherwise approved by the Agency.
- 28
- 29                   (2) Academic semester--A period of instruction that includes at least 15 weeks of
- 30                   instruction, unless otherwise approved by the Agency.
- 31
- 32                   (3) Academic term--An academic quarter, academic semester, or other progress
- 33                   evaluation period.
- 34
- 35                   (4) Academically related activity--An exam, tutorial, computer-assisted
- 36                   instruction, academic counseling, academic advisement, turning in a class
- 37                   assignment, or attending a study group that is assigned by the institution, or
- 38                   other activity as determined by the Agency.
- 39
- 40                   (5) Accountant--An independent certified public accountant properly registered
- 41                   with the appropriate state board of accountancy.
- 42
- 43                   (6) Act--Texas Education Code, Chapter 132, Career Schools and Colleges.
- 44
- 45                   (7) Address of record--In addition to the mailing address contained in the
- 46                   application for a certificate of approval, each career school or college shall

1 establish an e-mail address of record for a distribution list that consistently  
2 maintains a minimum of two current subscribers, with the format of the  
3 address to be "School#Director@xdomain," e.g., S1111Director@gmail.com.  
4

- 5 (8) Advertising--Any affirmative act designed to call attention to a school or  
6 program for the purpose of encouraging enrollment.  
7
- 8 (9) Agency--The unit of state government established under Texas Labor Code,  
9 Chapter 301, that is presided over by the Commission and administered by the  
10 executive director to operate the integrated workforce development system and  
11 administer the unemployment compensation insurance program in this state as  
12 established under the Texas Unemployment Compensation Act, Texas Labor  
13 Code Annotated, Title 4, Subtitle A, as amended. The definition of Agency  
14 shall apply to all uses of the term in rules contained in this chapter.  
15
- 16 (10) Appellant--The party or the party's authorized hearing representative who files  
17 an appeal from an appealable determination or decision.  
18
- 19 (11) Asynchronous distance education--Distance education training that the Agency  
20 determines is not synchronous.  
21
- 22 (12) Class or course--An identifiable unit of instruction that is part of a program of  
23 instruction.  
24
- 25 (13) Commission--The body of governance of the Texas Workforce Commission  
26 composed of three members appointed by the governor as established under  
27 Texas Labor Code §301.002 that includes one representative of labor, one  
28 representative of employers, and one representative of the public. The  
29 definition of Commission shall apply to all uses of the term in rules contained  
30 in this subchapter.  
31
- 32 (14) Coordinating Board--The Texas Higher Education Coordinating Board.  
33
- 34 (15) Course of instruction--A program or seminar.  
35
- 36 (16) Course time--A course or class period that is:  
37
- 38 (A) a 50-minute to 60-minute lecture, recitation, or class, including a  
39 laboratory class or shop training, in a 60-minute period;
  - 40
  - 41 (B) a 50-minute to 60-minute internship in a 60-minute period; or
  - 42
  - 43 (C) 60 minutes of preparation in asynchronous distance education.  
44
- 45 (17) Date of notice--The date the notice is mailed, unless good cause exists for the  
46 hearing officer to determine otherwise.

- (18) Date of request of hearing--The date on which the appellant or the hearing representative filed a written notice of appeal with the Agency by hand delivery, facsimile, or mail. If an appeal is mailed to the Agency, then the appeal is perfected as of the postmark date on the envelope containing the appeal request unless good cause exists for the hearing officer to determine otherwise. If an appeal is delivered by hand or facsimile after 5:00 p.m., the date of request shall be the next day.
- (19) Distance education course--Either a seminar or a program that is offered to non-residence school students via correspondence or other media from a remote site on a self-paced schedule, excluding programs using interactive instruction.
- (20) Distance education school--A school that offers only distance education courses.
- (21) Employment--A graduating or graduate student's employment in the same or substantially similar occupation for which the student was trained.
- (22) Good reputation--The possession of honesty and truthfulness, trustworthiness and reliability, and a professional commitment to the educational process and the training or preparing of a person for a field of endeavor in a business, trade, technical, or industrial occupation, as well as the condition of being regarded as possessing such qualities. In determining whether a person is of good reputation, the Agency is not limited to the following acts or omissions. The Agency may consider similar acts or omissions and rehabilitation efforts in response to prior convictions in making its determination. A person is considered to be of good reputation if the person:
  - (A) has never been convicted of a felony or any other crime that would constitute risk of harm to the school or students as determined by the Agency;
  - (B) has not been successfully sued for fraud or deceptive trade practices, or breach of contract, within the last 10 years;
  - (C) does not own or administer a school currently in violation of legal requirements, has never owned or administered a school with repeated violations, and has never owned or administered a school that closed with violations including, but not limited to, unpaid refunds; or
  - (D) has not knowingly falsified or withheld information from the Agency.
- (23) Hearing--An informal, orderly, and readily available proceeding held before an impartial hearing officer. A party or hearing representative may present



1 evidence to show that the Agency's determination should be reversed,  
2 affirmed, or modified.

3  
4 (24) Hearing officer--An Agency employee designated to conduct impartial  
5 hearings and issue final administrative decisions.

6  
7 (25) Hearing representative--Any individual authorized by a party to assist the party  
8 in presenting the party's appeal. A hearing representative may be legal counsel  
9 or another individual. Each party may have a hearing representative to assist in  
10 presenting the party's appeal.

11  
12 (26) Human Trafficking--The action or practice of illegally transporting people for  
13 the purposes of forced labor or commercial sexual exploitation, including all  
14 offenses referred to in Chapter 20A of the Texas Penal Code.

15  
16 (27) Job placement--An affirmative effort by the school to assist the student in  
17 obtaining employment in the same or substantially similar stated occupation  
18 for which the student was trained.

19  
20 (28) Master student registration list--A comprehensive list with an entry made for  
21 any person who signs an enrollment agreement, makes a payment to attend the  
22 school, or attends a class. The entry shall be made on the date the first of these  
23 events occurs.

24  
25 (29) Party--The person or entity with the right to participate in a hearing authorized  
26 in applicable statute or rule.

27  
28 (30) Program or program of instruction--A postsecondary program of organized  
29 instruction or study that may lead to an academic, professional, or vocational  
30 degree, certificate, or other recognized educational credential.

31  
32 (31) Refund--The completed payment of a refund such that the refund instrument  
33 has been negotiated or credited into the proper account(s).

34  
35 (32) Reimbursement contract basis--A school operating, or proposing to operate,  
36 under a contract with a state or federal entity in which the school receives  
37 payment upon completion of the training.

38  
39 (33) Residence school--A school that offers at least one program that includes  
40 classroom instruction or synchronous distance education.

41  
42 (34) Response deadline--Deadlines that fall on a weekend, an official state holiday,  
43 a state holiday for which minimal staffing is required, or a federal holiday are  
44 extended one working day.

- 1 (35) Sanctions--Administrative or civil actions, including, but not limited to,  
2 penalties, revocation of approvals, or cease and desist orders taken by the  
3 Agency against an entity in response to violations of the Act or this chapter.  
4
- 5 (36) School--A "career school or career college," as defined in the Act, that  
6 includes each location where courses of instruction shall be offered.  
7
- 8 (37) Secondary education--Successful completion of public, private, or home  
9 schooling at the high school level or obtainment of a recognized high school  
10 equivalency credential.  
11
- 12 (38) Seminar--A course of instruction that enhances a student's career, as opposed  
13 to a program that teaches skills and fundamental knowledge required for a  
14 stated occupation. A seminar may include a workshop, an introduction to an  
15 occupation or cluster of occupations, a short course that teaches part of the  
16 skills and knowledge for a particular occupation, language training, continuing  
17 professional education, and review for postsecondary examination.  
18
- 19 (39) Seminar school--A school that offers only seminars.  
20
- 21 (40) Small school--A "small career school or college" as defined in the Act.  
22
- 23 (41) Stated occupation--An occupation for which a program is offered that:  
24
- 25 (A) is recognized by a state or federal law or by a state or federal agency as  
26 existing or emerging;  
27
  - 28 (B) is in demand; and  
29
  - 30 (C) requires training to achieve entry-level proficiencies.  
31
- 32 (42) Student--Any individual solicited, enrolled, or trained in Texas by a school.  
33
- 34 (43) Suspension of enrollments--A sanction that requires the school to suspend  
35 enrollments, re-enrollments, advertising, and solicitation, and to cease, in any  
36 way, advising prospective students, either directly or indirectly, of the  
37 available courses of instruction.  
38
- 39 (44) Synchronous distance education--The Agency may determine distance  
40 education to be synchronous under the following conditions:  
41
- 42 (A) the training is conducted simultaneously in real time, or the training is  
43 conducted so that the manner of delivery ensures that even if the  
44 instructor and student are separated by time, the course time of  
45 instruction that the student experiences can be determined; and  
46

1 (B) there is consistent interaction between the student(s) and the instructor on  
2 a schedule that includes a definite time for completion of the program  
3 and periodic verifiable student completion/performance measures that  
4 allow the application of the progress standards of Subchapter L and  
5 attendance standards of Subchapter M of this chapter.  
6

7 (45) Title IV school--A career school or college that participates in student financial  
8 aid programs under Title IV, Higher Education Act of 1965 (20 U.S.C. Section  
9 1070 et seq.).  
10

11 (46) Tour--A required, in-person inspection of the facilities and equipment  
12 pertaining to a course of instruction.  
13

14 (47) Week--Seven consecutive calendar days.  
15

### 25 **§807.3. Memorandum of Understanding for Regulation of Schools.**

26  
27 The Act requires the Commission to execute a memorandum of understanding with the  
28 Texas Guaranteed Student Loan Corporation and each state agency regulating schools to  
29 reduce default rates at the regulated schools and to improve the overall quality of the  
30 programs. Copies are available at the Texas Workforce Commission, 101 East 15th  
31 Street, Austin, Texas 78778.

### 38 **§807.4. Waivers.**

39  
40 (a) Upon a showing of extreme extenuating circumstances, a school governed by this  
41 chapter may request a waiver from one or more requirements of this chapter. The  
42 Commission shall grant a waiver only upon a specific finding of good cause  
43 establishing that:  
44

45 (1) the imposition of the rule requirement from which the waiver is sought would  
46 cause undue economic hardship to the school and have a negative impact on

1 the ability of the school to provide the students with the skills and knowledge  
2 required for employment;

3  
4 (2) the quality of education shall in no way be diminished or sacrificed by the  
5 granting of the waiver; and

6  
7 (3) the granting of the waiver will in no way limit the statutorily required  
8 application approval criteria contained in §132.055 of the Act.

9  
10 (b) The Commission may revoke a waiver in the same manner as a revocation of a  
11 certificate of approval, if the Commission determines that the criteria contained in  
12 this section for a waiver no longer exists.

13  
14 (c) A school may appeal a requested waiver denial or revocation in accordance with the  
15 provisions of Subchapter D of the Act.

21 **§807.6. Processing Periods.**

22  
23 (a) The time periods for processing applications from schools, including small  
24 businesses, for certificates of approval, as well as approvals for representatives,  
25 school directors, and instructors, shall be in accordance with the following time  
26 periods.

27  
28 (1) The first period is the time from the receipt of an application to the date of the  
29 issuance of a written notice approving the application or outlining the reasons  
30 why the application is unacceptable. The time periods for each application are:

31  
32 (A) original certificate of approval--40 days;

33  
34 (B) renewed certificate of approval--40 days;

35  
36 (C) change in ownership certificate of approval--40 days;

37  
38 (D) original representatives--21 days;

39  
40 (E) renewed representatives--21 days;

41  
42 (F) school directors and instructors (approval contingent on issuance of  
43 school's approval)--40 days; and

44  
45 (G) school directors and instructors (approval not contingent on issuance of  
46 school's approval)--55 days.

- (2) The second period is the time from receipt of the last item necessary to complete the application to the date of issuance of written notice approving or denying approval of the application. The time periods for each application are:
  - (A) original certificate of approval--40 days;
  - (B) renewed certificate of approval--40 days;
  - (C) change in ownership certificate of approval--40 days;
  - (D) original representative (approval contingent upon issuance of school's approval)--21 days;
  - (E) original representative (approval not contingent upon issuance of school's approval)--21 days;
  - (F) renewed representative (approval contingent upon issuance of school's approval)--21 days;
  - (G) school directors and instructors (approval contingent on issuance of school's approval)--40 days; and
  - (H) school directors and instructors (approval not contingent on issuance of school's approval)--55 days.

(b) In the event the application is not processed in the time periods as stated in this section, the applicant has the right to request of the Commission full reimbursement of all filing fees paid in that particular application process. If the Commission does not agree that the established time periods have been violated or finds that good cause existed for exceeding the established periods, the request will be denied. Good cause for exceeding the period established is considered to exist if:

- (1) the number of applications for certificates of approval, representatives, school directors, or instructors as appropriate to be processed exceeds by 15% or more the number processed in the same calendar quarter of the preceding year;
- (2) another public or private entity utilized in the application process caused the delay; or
- (3) other conditions exist that give good cause for exceeding the established periods.

(c) If the request for full reimbursement authorized in this section is denied, the applicant may then request a hearing by appealing to the Commission for a

1 resolution of the dispute. The appeal will be processed in the same manner as other  
2 appeals involving schools pursuant to the Act.

25 proficiency, and uses criterion-referenced evaluation to measure achievement.

    - (D) with a 25 percent or more change within a 12-month period to the total number of hours, content, or lessons (examples: course time from 1,000 hours to 750, 600 hours to 900, 20 lessons to 30, 60 semester credit hours to 80).
  - (5) New seminar--A seminar:
    - (A) not previously offered;
    - (B) previously offered and then discontinued;
    - (C) with a revised objective; or
    - (D) with a 25 percent or more change in a 12-month period to the total number of hours of the approved seminar.
  - (6) Revised program or seminar--Revisions include changes in admission requirements, title, class title, objective description (but not the detailed objective), class course time or credit hours, or class hours of lecture, laboratory, or externship. Scheduling and price changes are catalog changes, not revisions.

42 demonstrates that the program's quality, content, and length reasonably and  
43 adequately imparts the job skills and knowledge necessary for the student to obtain  
44 employment in the stated occupation.

- 1 (g) A school may not solicit students, otherwise advertise, or conduct classes for a  
2 course of instruction prior to the Commission's approval of the course of instruction.  
3 Any such activity by the school, prior to the Commission's approval of the course of  
4 instruction, shall constitute a misrepresentation by the school and shall entitle each  
5 student in the course of instruction to a full refund of all tuition and fees paid by the  
6 student and release from all obligations.  
7
- 8 (h) The school shall establish and maintain a formal advisory committee of at least five  
9 members, unless the Commission approves a lesser number of persons in advance,  
10 for each type of program with course time in excess of 200 hours in length. At least  
11 annually, the committee shall evaluate the curriculum, instructional materials and  
12 media, equipment, and facilities to ensure they meet the needs of the job market. The  
13 school shall have written documentation of the evaluation available for review by the  
14 Commission. If the school does not follow an advisory committee recommendation,  
15 the school shall maintain written documentation of the justification for not following  
16 the recommendation.  
17
- 18 (i) If the applicant requests approval to measure courses of instruction in credit hours,  
19 the following conversion table shall be used.  
20
- 21 (1) One academic quarter credit hour equals a minimum course time of:  
22  
23 (A) 10 hours of classroom lecture;  
24  
25 (B) 20 hours of laboratory experience; or  
26  
27 (C) 30 hours of externship.  
28
- 29 (2) One academic semester credit hour is equal to a minimum course time of:  
30  
31 (A) 15 hours of classroom lecture;

33 (B) 30 hours of laboratory experience; or

35 (C) 45 hours of externship.

27 advertised.  
28  
29 (d) A school shall not use terms to describe the significance of the approval that specify  
30 or connote greater approval. Terms that schools may not use to connote greater  
31 approval by the Commission include, but are not limited to, "accredited,"  
32 "supervised," "endorsed," and "recommended." A school shall not use the words  
33 "guarantee," "guaranteed," or "free" unless approved in writing by the Commission.

35 (e) Any advertisement that includes a reference to awarding of credit hours shall include  
36 the statement, "limited transferability." Where a school has an arrangement with a  
37 college or university to accept transfer hours, such information may be advertised,  
38 but any limitations shall be included in the advertisement.

- 24 (d) A school shall not use endorsements, commendations, or recommendations by  
25 students in favor of a school except with the consent of the student and without any  
26 offer of financial or other material compensation. Endorsements shall bear the legal  
27 or professional name of the student.

- 29 (e) A school shall not use a photograph, cut, engraving, illustration or graphic in  
30 advertising in such a manner as to:

- 32 (1) convey a false impression of size, importance, or location of the school,  
33 equipment, or facilities associated with the school, or

- 35 (2) circumvent any of the requirements of this chapter regarding written or oral  
36 statements.

- 38 (f) Every advertisement must clearly indicate that training is being offered, and shall  
39 not, either by actual statement, omission, or intimation, imply that prospective

- 19 (12) veterans administration refund policy, if applicable;
- 20
- 21 (13) description of courses of instruction, including the number of hours of course
- 22 time of a seminar, seminar topic, lecture, lab, and externship, as well as credit
- 23 hours in each class, if applicable;
- 24
- 25 (14) description of each class;
- 26
- 27 (15) description of the grading policy, including requirements for graduation;
- 28
- 29 (16) description of placement assistance, if available;
- 30
- 31 (17) statement of policies regarding grievances; and
- 32
- 33 (18) a statement signed by the owner or director indicating that all of the
- 34 information contained in the catalog is true and correct.

- 36 (b) Any classes defined as self-paced shall be noted as such in the catalog.

- 38 (c) In addition to the information contained in subsections (a) and (b) above, the catalog

- 41 complete description of the following:

- 45 (2) the amount of tuition charged for each period;

3 (4) any other charges for each period.

5 (d) All changes to the catalog shall be disclosed to the Agency, using forms provided by  
6 the Agency. Failure to disclose changes may result in penalties and sanctions,  
7 including refunds.

43 offerings, and seminars are not required to grant credit for previous education and  
44 training.

- 1 (c) The school shall make appropriate adjustments to the program length and price  
2 based upon credit granted for previous education and training, where warranted.

- 4 (d) For a school having specific term-beginning dates, a school may not start students  
5 after the third day of classes during any given term, except in those cases where  
6 appropriate credit for previous education and training has been given according to  
7 the Act and this chapter.

10 requirements stated in the catalog in effect at the time of the student's enrollment.

33 enrollment agreement and catalog at the time of signing by the student;

38 loans, grants, or installment payments are involved.

A school shall clearly identify the payor, the type of funding, and the reason for the charges. These records shall be posted and kept current.
- (f) A school shall issue written receipts of any charges or payments to the student and maintain such records for review upon request by the Commission. Each separately charged item shall be clearly itemized on a student-signed receipt.

    - (D) Proof of a certified mailing to the address of the student's parent or legal guardian, if known and different from the student's last known or permanent addresses; or
  - (6) does not have course approval or the required certificate of approval from the Agency.

- 1 (b) To be considered a violation subject to refund under subsection (a)(1) - (6) of this  
2 section, a school's action shall be determined to be more than a technical error or a  
3 nonsubstantive change in operations.

18 purposes of calculating a student's refund.

- 20 (f) For all schools other than seminars, a student may cancel enrollment, request a full  
21 refund, and request a release from any obligations to the school within the first three  
22 scheduled class days.

- 24 (g) A school may withhold from the full refund required by subsections (a) - (c) and (f)  
25 of this section any amount provided for in statute as retainable by the school  
26 pursuant to Texas Education Code §132.061. More specifically, the school may  
27 withhold items of extra expense to the student referenced in §132.061(b)(6), as long  
28 as they are necessary for the portion of the program attended and are separately

4 (b) Any penalty assessed on a school's late payment of student refunds shall be  
5 disbursed in the following order of priority:

39       are available for Commission review.

41       (d) Degree granting schools shall maintain a copy of the certificate of authorization  
42       from the Coordinating Board for each authorized degree program.

44       (e) The Commission may conduct unannounced compliance inspections.

40 (d) For any programs not meeting a minimum employment rate for program graduates  
41 in jobs related to the stated occupation, as referenced in §807.131(b), the following  
42 graduated corrective actions will be taken:

44 (1) For a program not meeting the minimum employment rate for the first year, the  
45 school will be required to develop and submit a performance improvement plan  
46 acceptable to the Agency;

2 (2) For a program not meeting the minimum employment rate for the second  
3 consecutive year, but showing improvement of at least 50% of the difference  
4 between the reported rate and the minimum employment rate of the previous  
5 year, the school will be required to reexamine and submit modifications to the  
6 performance improvement plan acceptable to the Agency;  
7  
8 (3) For a program not meeting the minimum employment rate for the second  
9 consecutive year and not showing improvement of at least 50% of the difference  
10 between the reported rate and the minimum employment rate of the previous  
11 year, conditions will be placed on the school's certificate, which include:  
12  
13 (A) modification of the performance improvement plan; and  
14  
15 (B) suspension of new enrollment of students funded with Local Workforce  
16 Development Board-allocated funds in the program; and  
17  
18 (4) For a program not meeting the minimum employment rate for the third  
19 consecutive year, the Agency will revoke approval of the program.  
20  
21 (e) The Agency shall publish on its website information compiled from:  
22  
23 (1) data reported under subsection (a) of this section; and  
24  
25 (2) any other information collected about schools and programs deemed  
26 appropriate and useful to the public, which:  
27  
28 (A) assists a person in deciding whether to enroll in a school or in identifying  
29 or choosing which postsecondary institution, school, or college to attend;  
30 and  
31  
32 (B) addresses regulatory compliance and performance of schools.

34 (3) The Agency, to the extent practical, shall present the published information in  
35 a manner that is consistent among institutions, schools, and colleges; easy to

4 (1) the seriousness of the alleged violation;

10 (4) the timeliness of the complaint;  
11  
12 (5) the feasibility of investigations; and

21 (d) Unless good cause is shown, a complaint is timely only if it is filed with the Agency

23 the student withdraws, terminates, or graduates from the program that is the subject  
24 of the complaint. Good cause includes, but is not limited to, fraud.

26 (e) The investigation fee authorized by the Act is based on a per site visit. The school  
27 director shall be notified that an on-site visit was conducted when the investigation

8 includes at least the following topics.

- 10 (1) Five hours shall cover techniques of instruction including: qualities of a  
11 competent instructor, the learning process, methods of teaching, development  
12 of efficient teaching habits, demonstration teaching, the use of instruction  
13 material and training aids, course preparation, lesson plans, testing and  
14 evaluation, and the duration and frequency of lessons.  
15
- 16 (2) Two hours shall cover personality factors affecting the driver and pedestrian  
17 including: natural abilities; senses; mind and nerves; bones and muscles;  
18 knowledge of vehicle, road, traffic, and self; attitudes and emotions; reaction  
19 time; and reactions to alcohol, carbon monoxide, over-the-counter drugs,  
20 prescription drugs, illegal drugs, heart ailments, epilepsy, diabetes, insanity,  
21 exhaustion, tension, and monotony.  
22
- 23 (3) Six hours shall cover state laws as located in the Texas Motor Vehicle Law  
24 book relating to the operation of motor vehicles including: driver's license,  
25 vehicle registration, certificate of title, operation of vehicles, uniform act,  
26 miscellaneous offenses, and safety responsibility.  
27
- 28 (4) Eight hours shall cover driving procedures including: handling--city, rural,  
29 night, mountain, and freeway driving; fog, rain, sandstorms, and other  
30 hazardous weather conditions; road hazards and recovery procedures for slick  
31 roads; blowout hazards and running off the road; traffic signs, markings, and  
32 signals; use of rearview mirrors; vehicle braking and stopping distances;  
33 following distances; right-of-way, when and how to yield it; vehicle  
34 acceleration and deceleration; yielding right-of-way to emergency vehicles;  
35 driver signals; proper passing procedures; procedures and problems for passing  
36 on two and three-lane roadways; and super-size motorized equipment.  
37
- 38 (5) Three hours shall cover physical forces affecting the motor vehicle in motion  
39 including: forces of gravity; friction; acceleration, mass, and force; inertia and  
40 centrifugal force; kinetic energy and momentum; kinetic energy and braking;  
41 and horsepower and acceleration.  
42
- 43 (6) Two hours shall cover highway characteristics including: primary, secondary,  
44 expressway, freeway, farm or ranch road, two-way two-lane, two-way three-  
45 lane, two-way multilane, two-way multilane divided, one-way multilane,  
46 parking, and traffic controls. Traffic control topics consist of the following:

2 (A) sign topics including shape, color, location and importance;  
3  
4 (B) traffic marking topics including center and lane lines, no passing zone,  
5 transition markings, turn lane marking, stop lines, crosswalk lines, etc.;  
6 and  
7  
8 (C) signal topics including classification, location, type, timing.  
9  
10 (7) Two hours shall cover automobile systems and maintenance including:  
11 electrical system--generator, alternator, battery, lighting, and electric-powered  
12 equipment; cooling system--lubrication and fuel systems; power train--engine,  
13 transmission, and differential; brake system--wheels and tires, caster, camber,  
14 toe-in, balance, inflation, tire condition, and care; exhaust system; instruments  
15 and gauges; compartment adjustments--seat, ventilation, mirrors, headrests,  
16 seat belts, and shoulder harness; starting the engine and warm-up procedures;  
17 safety devices--door locks, headrests; and miscellaneous features--windshield  
18 wipers, heater, and defroster.  
19  
20 (8) Two hours shall cover behind-the-wheel elementary lessons with  
21 demonstration in an appropriate vehicle and practice to be performed in the  
22 presence of the instructor including: starting; steering; stopping; shifting gears;  
23 backing; turning--right and left; and parking and starting on grade.  
24  
25 (9) Six hours shall cover behind-the-wheel driving safety lessons with  
26 demonstration in an appropriate vehicle and practice to be performed in the  
27 presence of the instructor including: developing good seeing habits; speed  
28 control; safe following; lane driving and lane changing; intersections and right-  
29 of-way; proper signaling; correct turn procedures; detecting of and handling  
30 problems--vehicle, cycle, pedestrian; freeway driving--ramp use, entering,  
31 exiting, lane use, emergency stopping; parking procedures; entering traffic  
32 from parked position; and night driving.

34 (10) Two hours shall cover school and instructor approval requirements including  
35 the following: school approval requirements, instructor approval requirements,  
36 classroom and automotive equipment requirements, required student records,  
37 contract requirements, and department of instructors.

39 (11) Two hours shall cover specialized training regarding the following: students  
40 with physical, mental, or emotional handicaps; illiterate students; non-English-  
41 speaking students; and habitual violators and problem drivers.

30 filed with the Commission on or before the date the school files an original or  
31 renewal application for approval of the program with the Commission;

39 felony; of an offense of criminally negligent homicide committed as a result of  
40 the person's operation of a motor vehicle; of an offense involving driving while

21 **§807.341. School Closures.**

- 25 (1) written notification is received by the Commission from the school owner  
26 stating the school will close;

- 28 (2) Commission determines that the school facility has been vacated without prior  
29 notification of a change of address given to the Commission;  
30
- 31 (3) an owner with multiple school locations transfers all students from one school  
32 location to another school location;  
33
- 34 (4) the school dismisses all students, contrary to the school's class schedule as  
35 printed in the school catalog; or  
36
- 37 (5) the school fails to maintain the faculty, facilities, equipment, or courses of  
38 instruction on the basis for which approval was issued.  
39

40 (b) After the Commission determines that a school will close or is closed, the  
41 Commission will attempt to notify students concerning their options to accept a  
42 teach-out or to receive a proportional tuition refund based on available funds.  
43 Notification to students may include constructive notice in news media, student  
44 meetings, or mailings to students.  
45

1 (c) Each teach-out requires approval of the Commission to determine whether the course  
2 of instruction is available, reasonable, and comparable with the course of instruction  
3 of the closed school. The teach-out is subject to the following conditions:

- 5 (1) Transfers of students from a closed school to another school under the same  
6 ownership shall not constitute a teach-out.  
7
- 8 (2) In order to be eligible for a teach-out, students shall submit a signed statement  
9 of acceptance to the teach-out school by the deadline as established by the  
10 Commission.

- 12 (3) The school offering the teach-out shall give credit for all comparable training  
13 received at the closed school, as determined by the Commission.

- 35 (2) calculated after refunds or discharges from other funding sources have been

39 limitation of §132.242(e) of the Act; and

- 41 (4) disbursed for reimbursable teach-out expenses based upon remaining funds in  
42 the account.  
43
- 44 (d) Following the graduation or termination of the students from the teach-out school,  
45 the teach-out school shall determine actual expenses and submit a claim for

1 reimbursement to the Commission on or before the date provided in the application  
2 packet. The teach-out school shall:

3  
4 (1) not claim expenses for facilities, equipment, utilities, or other items which  
5 were owned, rented, used, or otherwise obligated by the school prior to the  
6 Commission's approval of the teach-out program, even though such items may  
7 be used for the teach-out program;

8  
9 (2) be limited to expenses for tuition and fees that are non-recoverable from all  
10 financial resources, including grants and loans; and

11  
12 (3) ensure that the sum of the tuition and fees paid to the student's account at the  
13 closed school and the teach-out school is the lesser amount the student would  
14 have been charged for the complete program at the closed school or the teach-  
15 out school.

16  
17 (e) For schools in their first two years of operation that have not been required to furnish  
18 financial statements to comply with §807.35(b), the payment to the tuition trust  
19 account shall be calculated at the rate determined by the Commission using the  
20 projected gross amount of tuition and fees, as required in §807.33(c), to be charged  
21 by the school for the year in which the payment is collected. Once the school has  
22 submitted the actual amount of tuition and fees collected by the school in compliance  
23 with §807.35(b), the Commission shall reconcile the projected and actual amounts of  
24 tuition and fees collected. Upon reconciliation, the Commission shall determine if  
25 the school is entitled to a refund or must pay an additional amount to the tuition trust  
26 account.

4 (1) The amount of administrative penalty or level of sanction necessary to ensure  
5 immediate and continued compliance with statutes and regulations;

7 (2) The conduct of the entity in taking all reasonable steps or procedures necessary  
8 and appropriate to comply with statutes and regulations and to correct the  
9 violation; and  
10  
11 (3) The entity's prior violations of statutes, regulations, or orders administered,  
12 adopted, or issued by the Commission.

14 (d) Notwithstanding subsections (a) - (c) of this section, the Agency shall order refunds  
15 pursuant to applicable statute and rules.

9 be bound by any findings or conclusions made by the disqualified or withdrawn  
10 hearing officer.

16 **§807.387. Hearing Procedures.**

17  
18 (a) The hearing shall be conducted in person in Austin, Texas, unless the parties agree to  
19 a telephonic hearing or request a different location.

20  
21 (b) The hearing shall be conducted informally and in such a manner as to ascertain the  
22 substantive rights of the parties. All issues relevant to the appeal shall be considered  
23 and addressed, and may include:

24  
25 (1) **Presentation of Evidence.** The parties to an appeal may present evidence that is  
26 material and relevant, as determined by the hearing officer. In conducting a  
27 hearing, the hearing officer shall actively develop the record on the relevant  
28 circumstances and facts to resolve all issues. To be considered as evidence in a  
29 decision, any document or physical evidence must be entered as an exhibit at  
30 the hearing. A party has the right to object to evidence offered at the hearing  
31 by the hearing officer or other parties.

32  
33 (2) **Examination of Parties and Witnesses.** After placing the witnesses under oath,  
34 the hearing officer shall examine parties and any witnesses and shall allow  
35 cross-examination to the extent the hearing officer deems necessary to afford  
36 the parties due process.

37  
38 (3) **Additional Evidence.** The hearing officer, with or without notice to any of the  
39 parties, may take additional evidence as deemed necessary, provided that a  
40 party shall be given an opportunity to rebut the evidence if it is to be used  
41 against the party's interest.

42  
43 (4) **Appropriate Hearing Behavior.** All parties shall conduct themselves in an  
44 appropriate manner. The hearing officer may expel any individual or party who  
45 fails to correct behavior the hearing officer identifies as disruptive. After

1                   expulsion, the hearing officer may proceed with the hearing and render a  
2                   decision.

3  
4           (c) Records.

- 5  
6           (1) The hearing record shall include the audio recording of the proceeding and any  
7           other relevant evidence relied on by the hearing officer, including documents  
8           and other physical evidence entered as exhibits.  
9  
10          (2) The hearing record shall be maintained in accordance with federal and state  
11          law.  
12  
13          (3) Confidentiality of information contained in the hearing record shall be  
14          maintained in accordance with federal and state law.  
15  
16          (4) Upon request, a party has the right to obtain a copy of the hearing record at no  
17          charge. However, a party requesting a transcript of the hearing record shall pay  
18          the costs of the transcription.

24           **§807.388. Postponements, Continuances, and Withdrawals.**

26          (a) The hearing officer may grant a postponement of a hearing for good cause at a  
27          party's request.

29          (b) A continuance of a hearing may be ordered at the discretion of the hearing officer in  
30          order to consider additional, necessary evidence or for any other reason the hearing  
31          officer deems appropriate.  
32  
33          (c) A party may withdraw an appeal at any time prior to the issuance of the final  
34          decision.

40           **§807.389. Evidence.**

- 41  
42          (a) Evidence Generally. Evidence, including hearsay evidence, shall be admitted if it is  
43          relevant and if in the judgment of the hearing officer it is the kind of evidence on  
44          which reasonably prudent persons are accustomed to rely in the conduct of their  
45          affairs. However, the hearing officer may exclude evidence if its probative value is  
46          outweighed by the danger of unfair prejudice, by confusion of the issues, or by



1 reasonable concern for undue delay, waste of time, or needless presentation of  
2 cumulative evidence.

- 3
- 4 (b) Exchange of Exhibits. Any documentary evidence to be presented during a  
5 telephonic hearing shall be exchanged with all parties and a copy shall be provided  
6 to the hearing officer in advance of the hearing. Any documentary evidence to be  
7 presented at an in-person hearing shall be exchanged at the hearing.  
8
- 9 (c) Stipulations. The parties, with the consent of the hearing officer, may agree in  
10 writing to relevant facts. The hearing officer may decide the appeal based on such  
11 stipulations or, at the hearing officer's discretion, may set the appeal for hearing and  
12 take such further evidence as the hearing officer deems necessary.  
13
- 14 (d) Experts and Evaluations. If relevant and useful, testimony from an independent  
15 expert or a professional evaluation from a source satisfactory to the parties and the  
16 Agency may be ordered by hearing officers, on their own motion or at a party's  
17 request. The cost of any such expert or evaluation ordered by the hearing officer  
18 shall be borne equally by the parties.  
19
- 20 (e) Subpoenas.
- 21
- 22 (1) The hearing officer may issue subpoenas to compel the attendance of witnesses  
23 and the production of records. A subpoena may be issued either at the request  
24 of a party or on the hearing officer's own motion.  
25
- 26 (2) A party requesting a subpoena shall state the nature of the information desired,  
27 including names of any witnesses and the records that the requestor feels are  
28 necessary for the proper presentation of the case.  
29
- 30 (3) The request shall be granted only to the extent the records or the testimony of  
31 the requested witnesses appears to be relevant to the issues on appeal.  
32
- 33 (4) A denial of a subpoena request shall be made in writing or on the record,  
34 stating the reasons for such denial.

40 **§807.390. Ex Parte Communications.**

- 42 (a) The hearing officer shall not participate in ex parte communications, directly or  
43 indirectly, in any matter in connection with any substantive issue, with any interested  
44 person or party. Likewise, no person shall attempt to engage in ex parte  
45 communications with the hearing officer on behalf of any interested person or party.  
46

- 1 (b) If the hearing officer receives any such ex parte communication, the other parties  
2 shall be given an opportunity to review any such ex parte communication.  
3
- 4 (c) Nothing shall prevent the hearing officer from communicating with parties or their  
5 representatives about routine matters such as requests for continuances or  
6 opportunities to inspect the file.  
7
- 8 (d) The hearing officer may initiate communications with an impartial Agency employee  
9 who has not participated in a hearing or any determination in the case for the limited  
10 purpose of using the special skills or knowledge of the Agency and its staff in  
11 evaluating the evidence.  
12

- 29 (a) Following the conclusion of the hearing, the hearing officer shall promptly prepare a  
30 written decision on behalf of the Agency.

- 32 (b) The decision shall be based exclusively on the evidence of record in the hearing and  
33 on matters officially noticed in the hearing. The decision shall include:  
34
- 35 (1) a list of the individuals who appeared at the hearing;  
36  
37 (2) the findings of fact and conclusions of law reached on the issues; and  
38  
39 (3) the affirmation, reversal, or modification of the determination.  
40
- 41 (c) Unless a party files a timely motion for rehearing, the Agency may assume  
42 continuing jurisdiction to modify or correct a hearing decision until the expiration of  
43 30 calendar days from the mailing date of the hearing decision.

10 appear at the hearing.

12 (c) The Agency may schedule a hearing on whether to grant the reopening.

14 (d) The motion may be granted if the hearing officer determines that the party has shown  
15 good cause for failing to appear at the hearing.

- 24 (a) A party has 30 calendar days from the date the decision is mailed to file a motion for  
25 rehearing. A rehearing shall be granted only for the presentation of new evidence.

27 (b) A motion for rehearing shall be in writing and allege the new evidence to be  
28 considered. The party shall show a compelling reason why this evidence was not  
29 presented at the hearing.  
30  
31 (c) If the hearing officer determines that the alleged, new evidence warrants a rehearing,  
32 a hearing shall be scheduled at a reasonable time and place.  
33  
34 (d) The hearing officer shall issue a written decision in response to a timely filed motion  
35 for rehearing.  
36  
37 (e) The Agency may assume continuing jurisdiction to modify, correct, or reform a  
38 decision until the expiration of 30 calendar days from the date of mailing of the  
39 hearing decision.

**§807.395. Finality of Decision.**

- (a) The decision of the hearing officer is the final decision of the Agency after the expiration of 30 calendar days from the mailing date of the decision unless within that time:
  - (1) a request for reopening is filed with the Agency;
  - (2) a request for rehearing is filed with the Agency; or
  - (3) the Agency assumes continuing jurisdiction to modify or correct the decision.
- (b) Any decision issued in response to a request for reopening or rehearing or a modification or correction issued by the Agency shall be final on the expiration of 30 calendar days from the mailing date of the decision, modification, or correction.
